ALL COUNTY BOARDS OF ELECTIONS

TO: Members, Directors & Deputy Directors

CENTRAL AND EXECUTIVE COMMITTEE REPORTS

Pursuant to R.C. 3517.04, the organizational meeting of a county central committee shall be held not earlier than six nor later than fifteen days after certification of election results by the board of elections (if applicable, certification includes recounts).

Enclosed are forms for reporting the names and addresses of all members and officers of the county central and executive committees of the major political parties. **These forms are to be sent to the secretaries of the respective political parties.** You may copy these forms as necessary. Also enclosed is a letter to be sent with the forms to each county central committee secretary.

Upon completion by the party secretary, the forms are to be returned to the board of elections.
Forward the original of each form to my office no later than June 30, 2006.

It is important that these forms be delivered to the committee secretary immediately. Please remind him or her of the importance of these reports and ask that they be returned as soon as possible.

TO: COUNTY CENTRAL COMMITTEE SECRETARY

Ohio Revised Code Section 3517.04 provides, in part, as follows:

In the case of a county central committee, the meeting shall be held not earlier than six nor later than fifteen days following the declaration of the results by the board of elections of the election of members of county central committees in that county.

In order for you to comply with this section, we have enclosed a set of forms that you must complete **and return to the board of elections no later than June 26**. The board will retain one copy and send the original copy to the office of the Secretary of State.

R.C. 3517.02 provides that each political party shall file with the office of the Secretary of State a copy of its constitution and by-laws, if any, within thirty days of adoption or amendment. Each such party shall also file with the office of the Secretary of State a list of members of its controlling committees, and other party officials within thirty days of their election or appointment.
