ELECTION EXPENDITURES
(R.C. 3501.11(N))

Each board of elections is required to make an annual report to the Secretary of State showing the expenditures made in administering elections. The reports from the boards of elections are used to prepare the Secretary of State's annual report to the Governor, mandated by R. C. 3501.05(O).

All expenses incurred during calendar year 2006 must be included in the report even though all bills for such expenses have not been paid.

It is important that the forms be filled in completely and accurately. **Please review and verify all totals ensuring they balance properly.** The forms have been compiled in an Excel format so that you may download the forms into another file, complete and email back to our office.

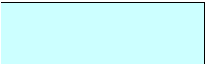

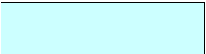
