To: All County Boards of Elections
Directors, Deputy Directors, and Board Members

Re: Uniform Days and Hours for In-Person Absentee Voting for the November 4, 2014
General Election

INSTRUCTIONS

All boards of elections are instructed to adopt the following as their business hours for early in-person (EIP) absentee voting¹:

- 8:00 a.m. to 5:00 p.m. – Tuesday, September 30, 2014 through Friday, October 3, 2014
- 8:00 a.m. to 9:00 p.m. – Monday, October 6, 2014²
- 8:00 a.m. to 5:00 p.m. – Tuesday, October 7, 2014 through Friday, October 10, 2014
- 8:00 a.m. to 5:00 p.m. – Tuesday, October 14, 2014 through Friday, October 17, 2014³
- 8:00 a.m. to 7:00 p.m. – Monday, October 20, 2014 through Friday, October 24, 2014
- 8:00 a.m. to 4:00 p.m. – Saturday, October 25, 2014
- 1:00 p.m. to 5:00 p.m. – Sunday, October 26, 2014
- 8:00 a.m. to 7:00 p.m. – Monday, October 27, 2014 through Friday, October 31, 2014
- 8:00 a.m. to 4:00 p.m. – Saturday, November 1, 2014
- 1:00 p.m. to 5:00 p.m. – Sunday, November 2, 2014
- 8:00 a.m. to 2:00 p.m. – Monday, November 3, 2014.

Any voter of the county may request and vote an absent voter's ballot (or a provisional ballot beginning October 7, 2014) in person during these regular business hours. Any voters in line at the end of these regular business hours must be permitted to make their application and vote.⁴
