To vote for a write-in candidate: completely darken the oval () to the left of the blank line and write in the candidate's name. Only votes cast for candidates who filed as write-in candidates can be counted. Do not write in a candidate's name if that person's name already is printed on the ballot for that same contest. Before casting your ballot, if you make a mistake or want to change your vote: return your ballot to an election official and get a new ballot. The proposed amendment would: - Require Ohio courts, when setting the amount of bail, to consider public safety, including the seriousness of the offense, as well as a person's criminal record, the likelihood a person will return to court, and any other factor the Ohio General Assembly may prescribe. - Remove the requirement that the procedures for establishing the amount and conditions of bail be determined by the Supreme Court of Ohio. If passed, the amendment will be effective immediately.
