2022 Annual¹	Jan. 31, 2023 to disclose activity through Dec. 31, 2022 .
Pre-Primary	April 20, 2023 to disclose activity through April 12, 2023 .
Post-Primary	June 9, 2023 to disclose activity through June 2, 2023 .
Pre-Special	July 27, 2023 to disclose activity through July 19, 2023 .
Semiannual²	July 31, 2023 to disclose activity through June 30, 2023 .
Post-Special	Sept. 15, 2023 to disclose activity through Sept. 8, 2023 .
Pre-General	Oct. 26, 2023 to disclose activity through Oct. 18, 2023 .
Post-General	Dec. 15, 2023 to disclose activity through Dec. 8, 2023 .
2023 Annual	Jan. 31, 2024 to disclose activity through Dec. 31, 2023 .

This is based on the following **2023** election dates:

2023 Primary - May 2, 2023 | 2023 Special - August 8, 2023 | 2023 General - November 7, 2023

Activity related to special elections may require reporting on different dates. Filing entities submitting reports to a county board of elections should contact the board for special election dates and filing deadlines not included on this calendar.

¹ R.C. 3517.10(A)(3) The 2022 annual is not required of any filing entity for which a 2022 post-general is required.

² R.C. 3517.10(A)(3) Requires the semiannual to be filed by statewide and county candidates in non-election years and completely exempts all judicial candidates.

2023 Campaign Finance Calendar

- Jan. 20** Secretary of State and boards of elections must send notice to candidates required to file annual campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- April 10** Secretary of State and boards of elections must send notice to candidates required to file pre-primary campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- May 30** Secretary of State and boards of elections must send notice to candidates required to file post-primary campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- July 21** Secretary of State and boards of elections must send notice to candidates required to file semiannual campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- Oct. 16** Secretary of State and boards of elections must send notice to candidates required to file pre-general campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
- Dec. 5** Secretary of State and boards of elections must send notice to candidates required to file post-general campaign finance reports.....R.C. [3517.10](#), [3517.11](#)

- Jan. 19** Secretary of State and boards of elections must send notice to candidates required to file annual campaign finance reports.....R.C. [3517.10](#), [3517.11](#)
